### ADR 680: Cross-Border Family Mediation Training – Parenting Plans\*

**Dates:** April 1-3, 2020

**Time:** 9:00 a.m. – 5:30 p.m.

This advanced training course will provide knowledge to family mediators who are interested in how to address cross-border issues that arise in crafting parenting plans. This course will help family mediators spot potential cross-border issues that require additional discussion and consideration between the parents, and help the family mediators to have a more sophisticated understanding of how to approach these complex situations. The course will cover the legal and practical aspects of international custody, child relocation, and child abduction that may arise when a family's background includes more than one jurisdiction.

If you are interested in registering for ADR 680, we encourage you to register early (enrollment is limited). In order to reserve your space, a \$200 (non-refundable) deposit or the full registration fee is required.
